Dear Bro. Overbey:

I am sending you the financial report this month with this let-ter. I have paid the workers here and have wired the salaries nere and have wired the salaries to the workers in the Acre territory but I have not received conformation from Miguel yet. I also have on this report 200 cr. that I paid for Laudomiro. Ordinarily I would not have taken this but I have had quiet a few doctor bills this month. Helen has had to have some shots for an inflammation in her breast and the two youngest of my children are suffering with boils. Mary is covered with them right now. They are break-ing out as fast as one heals. The doctor said that he thought that it was from the intense heat that we have here. My son is also having his teeth fixed. I took him to the dentist at home but the dentist there said there was nothing that you could do about them. He has been having toothaches here lately and I had to take him to the dentist.

I also have in this report 327.20 cr. charges for the changing of the title to the property here from Billy's name to that of the mission. It is not through yet; there is more to do. I have been going down every day for the last three weeks and they send ast three weeks and they send me from one place to another and every place I go they charge me a little more money. I have only gotten three receipts, one for 90 cr. and one for 15 cr. and one for 21.20 cr. The rest of the charge I have no receipt for. I have tried to get a receipt for the rest but they say they are charging for their services for charging for their services for drawing up the papers, etc., and do not have to give me receipt. There is nothing that I can do about it. They are that way with everything here, in the customs office they did the same thing. It does no good to be a same thing. It does no good to be a same thing they are full of protest because they are full of graft all the way up to the top. I go down again tomorrow, I (Next page, Column four)

Here Is A Most Interesting Letter From Marguerite Telling Of God's Goodness In Bringing Them Home

Dear Bro. Overbey:

It is exactly one month today since we left Iquitos. The last two weeks before our depart-ure were very busy ones—packing, disposing of some of our things, etc. The Lewises very kindly offered to turn over the things we had sold to their things we had sold to their rightful owners after we had left. In that way we were able to stay in the house up to the time the plane left, and not have too much upheaval to upset father for the journey. Most of the members of the congregation came to tell us goodbye the week previous to our going, so as not to make father nervous at the last min-

An American friend who has a new Chevrolet Pick-up with canvas cover came to take father to the Airport. His cot fit very nicely in the truck bed. We had arranged previously with the doctor who had been treating him to accompany us on the plane as far as Lima, and he was very helpful in getting our medical papers fixed up.

Crossing the Andes is quite a problem for anyone with a heart ailment, due to the very high altitude which the planes fly and the lack of pressurized cabins on the planes. A certain part of the journey is flown at an altitude of from 18,000 to 22,000 ft. To avoid as much danger as possible we arranged with the airline to fly a longer route over which it would not be necess-ary to fly so high. Dr. Herbert Money, secretary of the National Evangelical Council of Peru, made these arrangements for us in Lima. Also the doctor in Iquitos suggested that an extra sup-

ply of oxygen be provided in case of need and this was also arranged for by Dr. Money. As the re-routing of the plane in-volved a longer distance and therefore required more time, we were charged for the operation cost of the plane for the extra time involved. All of these arrangements had to be made well in advance of the day set for leaving. The Dr. had to get a leave of absence; the plane company had to arrange with civil aviation authorities for flying a different route on this particular date. The airline had to be reminded not to forget the extra oxygen tank and mask -Dr. Money told me later that this oxygen mask proved to be more difficult to arrange for than the re-routing of the plane. The Dr. who accompanied us said it was a special kind which made it possible to keep check the normal or abnormal breathing of the patient without disturbing him. Reservations out disturbing him. Reservations had to be made for the plane leaving Lima. Up to the night prior to our departure we had not been advised as to best proceedure for getting an ambulance to meet the plane in Lima and I had to contact Dr. Money by redictaleshore to find out by radio-telephone to find out about this. He told me he would meet the plane with an ambu-

We left Iquitos about 12:30 P. M. on August 5th. The Lew-ises and a few other friends saw us to the plane. Father was put directly from the truck on to the plane. The cot was tied down with ropes to keep it from slip-ping around. The pilot had instructions not to fly any higher than necessary. For the first hour he flew at an altitude of

about 600 ft. below the clouds to avoid bumps. Once we start-ed climbing they adjusted the oxygen mask on him. Our high-est flying was at about 11,000 ft. Father made the trip fine with very little difficulty. The doctor checked him from time to time and was very pleased and surprised at the way he stood the trip. Dr. Money met us at the plane with the ambulance with several employees of the airline who came aboard to see how he made the trip. The Doctor, Mother and I went along with father in the ambulance an airline employee got our baggage and turned it over to Dr. Money who checked our papers through the proper channels. The doctor stayed at the same Pension that we did.

From the Pension Dr. Money and I went immediately to the Pan American Grace Airways office to confirm our reserva-tions for Aug. 7. They took charge of our passports so as to get exit and re-entry permits. The next two days were busy ones making final arrangements etc. The weather was cold and dreary, quite a change from Iquitos weather.

Our plane was to leave at 7:05 P. M. Aug. 7th. I was told to pick up our passports at 4: P. M., and take the luggage to the airport at 6:00 for customs inspection, checking through immigration authorities, etc. Fa-ther and Mother were to come later with the doctor - special permission was obtained for him permission was obtained for film to go aboard to see father set-tled — They were to go direct-ly from the ambulance to the plane. When I went to the airline office at four I was told

(Preceding page, Column four) someone had failed to sign the passports but to come back at six and they would be ready. Since it was a long way for me to have to come back. Dr. Money offered to get the passports ar come by our Pension and pick up our baggage and go from there to the airport. When he got there he said the passports were supposed to be at the air-port by seven. I still did not think about anything having gone wrong, but when we got to the airport about the first thing we heard was: "Are you the people whose passports have been lost?" Needless to say, this was quite a shock. Fortunately it was the airline who had lost them, and not us. They were responsible. It was a man from the American Embassy who first informed me the passports were missing, but he made haste to assure me that I should not worry as they would wire ahead to the immigration authorities in Miami explaining the situa-tion, and Pan American would give me a letter to present on arrival. I remembered having old cancelled passport in my suitcase, so they asked me to get it out and it was attached to the letter of identification. From that time on that airline couldn't do enough for usseemed to be functioning for the Hallums convenience. They asked me if I would like to go aboard ahead of the other pas-sengers. When I said I would rushed me through the formalities of checking out of the country, allowed Dr. Money to accompany me to the plane, etc. We saw father well fixed in his berth, and a few minutes later they brought the letter of identification to me and again assured me I had nothing to worry about. Everything happened so fast and smoothly, father never knew anything about it.

The night flight was a smooth one. Once the co-pilot came back to see how father was standing it. He said they were trying to make it as smooth as possible and if they saw they might run into rough weather, they would let us know so we could give him a sedative. At times it seemed they were literally going around every cloud.

We arrived in Miami next morning at 6:45. An ambulance was called to keep father in during the scheduled 1 1/4 hr. lay-over. A special agent of Pan American met us at the foot

of the steps and said he had been told to take care of us. We told him we had reservations for the 8:00 o'clock plane for N. O. He checked on that and found that no arrangement space occupied by a stretcher, so we had to buy a ticket for another seat. He got our things through Customs without dif-ficulty. The immigration authorities didn't even look at the letter of identification — just asked if were American citizens. We got on the plane which was to take us to N. O. but one of the motors did not function pro perly so we had to return to the airport. Later we were told there would be an 8 hr. delay. An employee came aboard and us they would send for an ambulance to take us to a hotel and that they would try to get us on the next plane out — 12:45 P. M. Father had a good long rest and sleep in bed, then at 12 the ambulance came back

and took us to the plane which left at 12:45. One part of the trip was a little bumpy and the co-pilot came back and apologized, saying they were trying miss the bumps, but occasionally they were unavoidable. Between 3 and 3:30 P. M. we reached New Orleans where my brother and family met us with one of his father-in-law's ambulances

When we got to Hammond about 5 P. M. we found the W. M. U. of the church had prepared and left a big dinner for our arrival at my brothers home. Everyone was very happy that father had stood the trip so well.

The house which we had been offered when we thought we would be coming in April, was rented to someone else so we had no idea where we would be living. However, the day after we arrived we were told the house had been vacated the day before. When we moved in we found the pantry well stocked, with most everything imaginable-the Sunday school this

The doctors give encouraging reports as to fathers condition. Already he is able to sit up for a short while several times a day. Yesterday he took a couple of steps - his first in about 6 months.

(Preceding page, Column one) hope that that is the last that I have of this thing. I had it put in the name of the mission because I thought that it would be best that way. It cost a little more money and a lot more trouble but I think it will be better this way in the end.

I took the liberty of calling Walter back from Codajaz when Billy said that he was leaving. He came back but said that he felt that he should go back very soon as the Pentecostalists were trying to move in on the work there. They have a pastor that is the worst one that I have ever seen. He stays here in Manaus all the time and never goes to church while he is here. So it was necessary for Walter to go back. I gave him 300.00 cr. and he went back but he no sooner than got there than he took sick and had to come back. He had been here about three weeks when he had a heart attack and had to take it real easy for awhile this week. I gave him some medicine for his heart as he seems to have the same trouble that my dad has. It did him a lot of good.

There were two saved in Codajaz awaiting for baptism and two reconciliations. I have not heard from Cruzeiro Do Sul yet. The work here is progre ing nicely, we had one recon-ciliation here. John Dias seems to be making a good pastor. He does a lot of work such as mak-

does a lot of work such as making calls and other things.

I hope that everything is prospering with you at home and that you had a good vacation and feel more like returning to your work now. Tell me from time to time about the progress you are making on the

church building.

I guess the Hallums are home now. I hope that they are comfortably settled by now. Just getting home must have made them feel a lot better.

I'm getting along very well in this language now. My teacher says that I am the best pupil says that I am the best pupils that he has ever had. It seems so good to be able to talk to the people now. I hope to start preaching in the near future. I don't know just when but I hope I get up the courage to start soon. I get along all right when I am talking with some one but it is easier to talk to someone than it is to preach, for when you talk to someone they sort of help you along by telling you what to say. You may not realize it but when you are talking to someone you re-peat quite a bit of what they say. Take notice sometime, it will surprise you. For instance when someone asks you how you feel you say, "I feel fine." Actually the other person has in a way told you what to say, although I never realized that un-til I came here. That is why I

hesitate to start preaching. I'm afraid that I would start and not be able to go on coherently. The people here want me to begin now but I don't think I'm quite ready to yet.

I have not received the medical manual yet. I probably never will. I found out the books of that type seldom reach the person they are sent to. It is such a pity that there is so much graft here, that it is even a risk to send anything by mail. a risk to send anything by mail. Actually this doesn't reflect the character of the people here. As a general rule the people here are very nice. We have some people here that steal, etc., but don't we also at home? The wonder to me is not that they do the things they do, the wonder is that they don't do more. If you could see the misery that these people live in and how they go constantly in want and many, many times they go hungry, you would think before you would condemn them. What touches my heart is that they would condemn them. What touches my heart is that they have so little and yet when I have so little and yet when I go over to their house they are willing to share with me what they have. Bro. Overbey, it isn't like it is at home when these people give you something they have to do without themselves. Yet they give gladly, because they want to. It hurts when you realize that they think that you are good, and deep down within yourself you know that they have suffered more than you ever have and that they have been persecuted for what they believe more than you ever have and went hungry many times because they could not find work because of what they believed, and you know that any one of them is a far better Chris tian than you are. I know how Brother Brandon felt when he said they made such great Christians here. It is not that they live any holier life than the saints at home, but they have to suffer so much more for bearing the name of Christ than we do at home.
